Introduction

The Southwest Arizona Futures Forum met for their 11th Plenary Session at The Yuma Main Library on January 19, 2012. Approximately 73 people attended the Plenary to address the topic **Every Vote Counts Increasing Voter Participation in Yuma County**. An informative executive summary of the topic which was inspired by the O' Connor House was prepared by Yuma County Administrator, Robert Pickels.
